Q2 Fiscal 2016 Guidance

Ambarella expects revenue for the second quarter of fiscal year 2016, ending July 31, 2015, to be between \$79.0 million and \$83.0 million. The company estimates non-GAAP net income for the first quarter to be between \$26.0 million and \$28.0 million. Non-GAAP gross margins are expected to be between 63.5% and 65.0% in the first quarter.

<u>Note</u>: Non-GAAP net income and non-GAAP gross margins exclude the impact of stock-based compensation and the associated tax impact. The Company has not reconciled non-GAAP net income and non-GAAP gross margins to GAAP net income and GAAP gross margins because these items cannot be reasonably predicted.
